V. Presentation of Bylaw Amendment To Strike Previous CCSGA Service as a Requisite for Presidential Candidacy

Ian: To be clear this also strikes the requirement of attending 3 full council meetings? Ethan: Yes

Max: Part of the impetus of striking it is, that if we don't we would have to abide by the restrictions when we have presidential elections block 6

Dani: Can you speak to how experience plays a role in the job?
